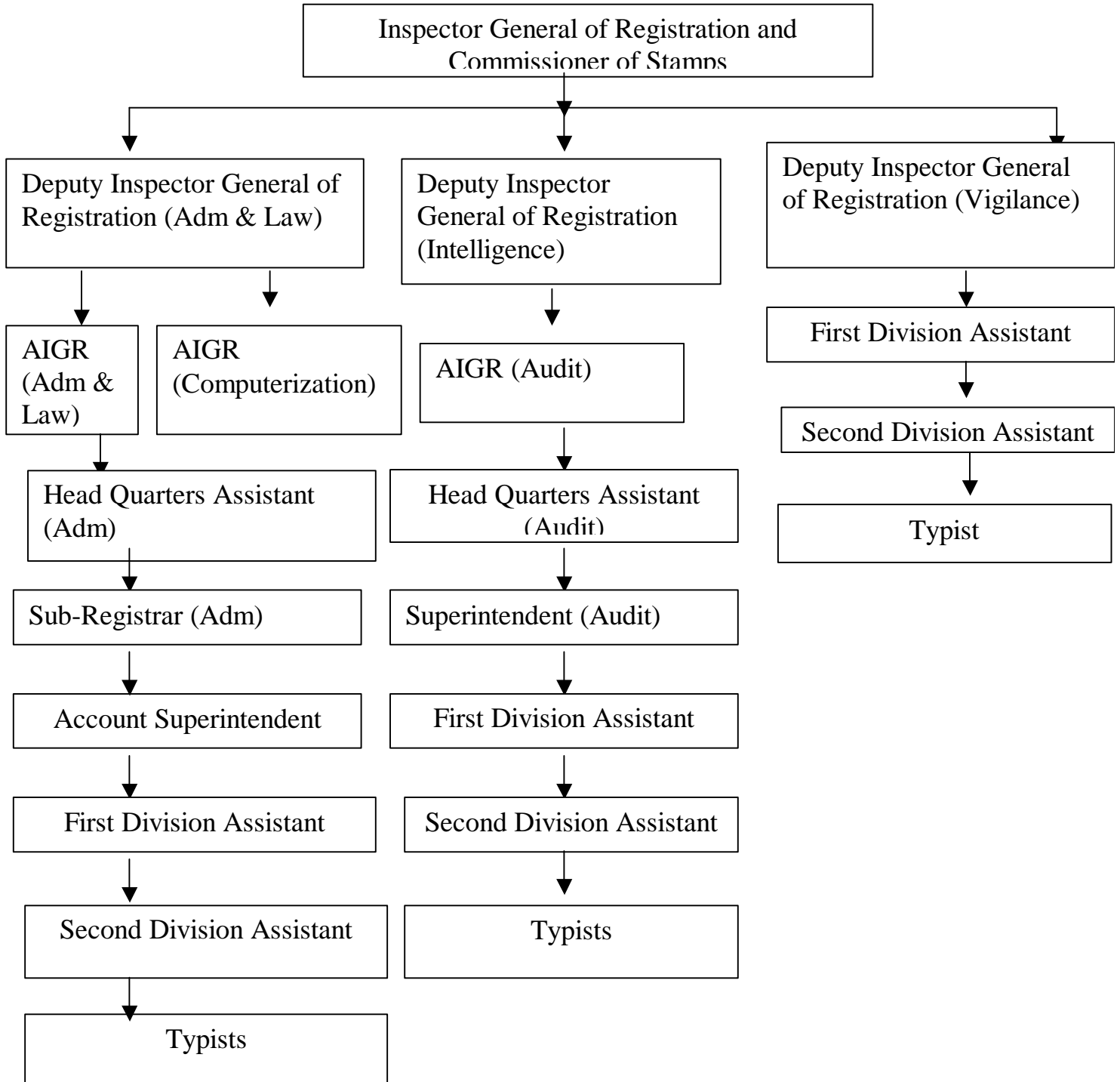


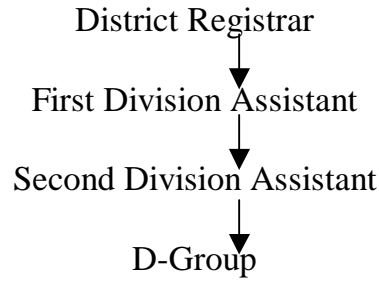

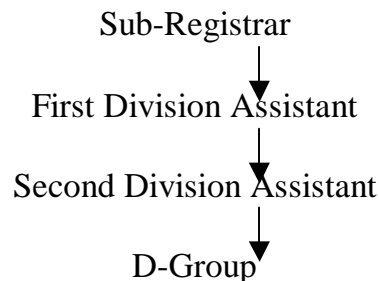

1. Within 10 days from the date of receipt of the application for a search of 15 years (manually).
2. Within a day if the search is for one year (manually).
3. Within 20 minutes, for the period the Encumbrance Certificate Data is held in the digitized form (EC Data held in the digitized form from September 2003 only).
