NOTIFICATION

No. RD 58 MUNOMU 2010, Bangalore, dated: 1st April, 2010

In exercise of the powers conferred by section 78 of the Registration Act, 1908(Central Act 16 of 1908), the Government of Karnataka hereby makes the following amendments to Notification No. RD 403 ESR 85, dated: 27th May 1986 as amended by Notification No. RD 184 MUNOMU 97, dated: 1st April 1997, RD 254 MUNOMU 98, dated: 31-03-1998, RD 467 MUNOMU 1998 dated: 23rd February 1999, RD 169 MUNOMU 2000, dated: 31st March 2000, RD 164 MUNOMU 2000(I) dated: 31st March 2001, RD 141 MUNOMU 2002, dated: 30th March 2002, RD 134 MUNOMU 2003, dated: 31-03-2003, RD 64 MUNOSA 2001(P), dated: 17-12-2003, RD 90 MUNOMU 2002(II) dated: 03-04-2005, RD 171 MUNOMU 2007, dated: 11-08-2008 and RD 67 MUNOMU 2009 dated: 27-05-2009; as follows, namely:-

In the said notification, in the Table of fees:-

1. In Article I.-

(a) in Note 1-a, in clause (iii) and the entries relating thereto, for the words and figures "Rs.5/- for every Rs.1000/- or part thereof, subject to a maximum of Rs.10,000/-", the following shall be substituted, namely:-

"Re.1/- for every Rs.1,000/- or part thereof subject to maximum of Rs.10,000/- but not less than Rs.100/-".

(b) in Note (3), for the entries relating thereto before the "explanation", the following shall be substituted, namely:-

"In the case of leases, the amount or value on which the ad-valorem fee is to be assessed is, the amount or value on which the stamp duty is assessed;

for leases not exceeding thirty years; rupees 5/- for every rupees 1000/- or part thereof but not less than rupees 100/-;

Provided, that in case of leases of residential properties not exceeding one year; rupees 5/- for every rupees 1000/- or part thereof subject to a maximum of rupees 100/-;

Provided further that in case of leases executed among family members; a fixed fee of Rs. 500/- is to be levied".

This Notification shall come in to force with effect from 01-04-2010.
